The author presents an alternative history in which Germany, under the leadership of the leader Adolf Hitler, do not lose the World War II, but are in a state of "cold" war with the Allies. After the extermination of Jews and Slavs and the normalization of political relations within the country, Adolf Hitler aims to make a historic agreement with the President of the United States. Harris presents a vision of what might have happened if the Allies would not defeat the Third Reich. He points the way alternative history about the outcome of World War II and explores the design of the past. The considered events and alternative aspect help to understand past events, their causes and effects. In the alternate history, the historical process compared to the branching roads reveals, in which moments of these paths diverge, in what direction and to which decisions they lead. The main vocation of alternative history is a historiosophical reflection. The simulation of the potential paths of historical development helps to understand the mechanisms of history and brings to light the causes and circumstances of the actual events and historical phenomena. In

reaction to the Irving v. Penguin/Lipstadt (winter, 2000) trial, the editors of this volume sought to provide a text that moves away from the Holocaust itself to ask broader questions about the stubborn persistence of anti-Semitic invective and historical distortion despite legal verdicts to the contrary, historical correctives and media reportage. For many, the name Adolf Eichmann is synonymous with the Nazi murder of six million Jews. Alongside Adolf Hitler and Heinrich Himmler, he is probably the most infamous of the Nazi murderers; unlike them, the aura linked to his name is that of the ultimate evil that may lurk in each and every one of us. This understanding can be attributed above all to Hannah Arendt, and her seminal book, Eichmann in Jerusalem: A Report on the Banality of Evil, in which she suggested that Eichmann and many bureaucrats like him never actually realized what they were doing: they were thoughtless rather than consciously evil. By taking this position, Arendt rejected the biblical story of Genesis, which sets the ability to distinguish between right and wrong at the very core of being human. Only in the interval between late September and late October 1941 did the desire to "remove" the Jews intersect with the discovery of acceptable means of killing them on a large scale and with the euphoria of expected victory in Russia, all of which followed on from two years of 'race war' and 'racial imperialism' in eastern Europe that prepared 'ordinary Germans' for this fateful task. The International Commission on the Holocaust in Romania was established in October 2003 on the initiative of Ion Iliescu, the President of Romania; this final report was presented to him in November 2004. Yet Himmler holds a peculiarly memorable place in the roster of Nazi war criminals: he was the man most closely associated with the creation and operation of the Final Solution, the programme of formal mass murder responsible for the deaths of six million Jews in death camps. Thus, to understand the Holocaust it is first necessary to understand Himmler, and it is this *The Architect of Genocide* at last permits us to do. Drawing on thousands of published and unpublished sources--ranging from the Nuremberg War Crimes trial records to papers held in the Central State Archives of the October Revolution of the Ukrainian SSR in Kiev--Breitman shows us the man himself, growing from unlikeable boyhood to be the perfect bureaucrat, seemingly the antithesis of the mad policies he espoused. At the same time, with unchallengeable authority, he presents us with the hitherto mysterious and much--debated facts about the origins of those policies, establishing among other things that before the war, Himmler had plans to murder all German Jews who would not- or could not--leave the country and that as early as 1939, Himmler was considering the use of gas chambers and crematoriums. November 9th 1938 is widely seen as a violent turning point in Nazi Germany's assault on the Jews. An estimated 400 Jews lost their lives in the anti-Semitic pogrom and more than 30,000 were imprisoned or sent to concentration camps, where many were brutally mistreated. Thousands more fled their homelands in Germany and Austria, shocked by what they had seen, heard and experienced. What they took with them was not only the pain of saying farewell but also the memory of terrible scenes: attacks by mobs of drunken Nazis, public humiliations, burning synagogues, inhuman conditions in overcrowded prison cells and concentration camp barracks. The reactions of neighbours and passersby to these barbarities ranged from sympathy and aid to scorn, mockery, and abuse. In 1939 the Harvard sociologist Edward Hartshorne gathered eyewitness accounts of the Kristallnacht from hundreds of Jews who had fled, but Hartshorne joined the Secret Service shortly afterwards and the accounts he gathered were forgotten – until now. These eyewitness testimonies – published here for the first time with a Foreword by Saul Friedländer, the Pulitzer Prize historian and Holocaust survivor – paint a harrowing picture of everyday violence in one of Europe's darkest moments. This unique and disturbing document will be of great interest to anyone interested in modern

Abe Korn was only 16 when the Nazis invaded his hometown of Lipno, Poland, on the first day of World War II. He survived the entire war as a Jewish prisoner, enduring two Nazi ghettos, eight concentration camps, and a 45-day Death March from Auschwitz. Astonishingly, Abe kept his sense of human dignity- with gangrenous feet he struggled to stay on the healthy workers list; with scarce supplies he bargained for food and coal and helped others survive. Abe never gave up hope. He always believed he could live one more day, and on April 11, 1945, when Buchenwald was liberated, Abe was finally free.
